

## Safety information On the contamination of Compressors, Vacuum Pumps and Components

### Scope of application and purpose

The enclosed declaration for repair of the compressors, vacuum pumps and components aims to inform the contractor about possible contamination.

Based on this information the contractor can take the necessary protections in the execution of the repair.

Note: The same regulations apply to repairs on site.

### Preparing the shipment

Before dispatch of the aggregate the operator must fill out the following declaration completely and attach the shipping documents. The shipping instructions which are indicated in the respective operating instructions are to be observed, such as:

- Drain resources
- Remove filter inserts
- Seal all openings airtight
- packed appropriately
- Dispatch in suitable transport container
- Make sure that the declaration of contamination is visibly attached outside on the packaging

#### **Declaration of Contamination of Compressors, Vacuum Pumps and Components**

The repair and / or servicing of compressors, vacuum pumps and components will be carried out only if a correctly declaration has been submitted. <u>Non-completion will result in delay.</u> The manufacturer can refuse to accept any equipment without a declaration.

A separate declaration has to be completed for each single component.

This declaration may be completed and signed only by authorized and qualified staff.
